COMPLAINT CAUSE CORRECTION REAR AXLE-GENERAL - CHANGE OUT BOTH DIFFERENTIALS, SAVE OIL INTO CLEAN PANS



46 JACKED UP TRUCK AND PUT FRONT DRIVE AND REAR DRIVE ON JACK STANDS. TOOK DOWN ENTIRE DRIVELINE AND MARKED WITH RED PAINT. DRAINED BOTH FRONT AND REAR DIFFERENTIALS INTO CLEAN PANS. TOOK OFF HUB COVERS AND TOOK OUT DRIVE AXLES AND LABLED. REMOVED ALL MOUNTING BOLTS FROM DIFFS AND PUT IN PARTS TRAYS AND LABLED. USED HOIST TO GET DIFFS OUT. CLEANED OUT BOTH DIFFS AND SCRAPED OFF SEALING SURFACES. FOUND A LOT OF METAL PIECES IN FRONT. 46 REPHRASE I ONLY TOOK OFF DRIVELINE UP TO HANGER BEARING. DID NOT GET A CHANCE TO TAKE THE REST DOWN. GOT THE NEW DIFFS FROM PARTS I THEN BEGAN WITH THE FRONT AND MADE SURE THE INSIDE WAS NICE AND CLEAN I THEN GOT MY GUIDE STUDS IN AND MY YOLKS SWITCHED AROUND. I USED SILICONE ON MATING SERVICE THEN I WENT ON WITH THE DIFF. ONCE WE GOT IT ON AND FLUSH I BEGAN TORQUING DOWN THE BOLTS. MAKING SURE WE WENT IN STRAIGHT AND NICE LIKE I REPEATED PROCESS WITH THE REAR DRIVE AXLE AS WELL I INSTALLED A NEW DRAIN PLUG ON THE FRONT ONE DUE TO OLD BEING STRIPPED I MADE SURE THE THREADS GOING IN WERE FINE AND THREADED THE NEW ONE IN. 152 ASSISTED TRISTAN IN MOUTING NEW DIFFERENTIALS. INSTALLED NEW U-JOINTS ON DRIVESHAFTS. DRIVE LINE WILL NEED GREASED AND DIFFS FILLED. 46 FILLED HUBS WITH DIFF FLUID THEN ROTATED TO 4 O' CLOCK. PUT NEW SHOES ON ALL DRIVES THEN PUT DRUMS ON. HAD TO HOOK UP SHOP AIR TO AIR UP TRUCK THEN SET ALL DRIVE SLACKS. PUT WHEELS ON AND TORQUED LUGS TO SPEC. PUT HUB AND LUG COVERS BACK ON ALL DRIVE WHEELS. USED HOIST TO PUT OLD DIFFS ON PALLETS THEN TOOK BACK TO PARTS FOR CORES. TOOK ALL OLD BRAKE SHOES BACK TO PARTS FOR CORES. 46 PUT REAR DIFF OIL INTO 5 GAL BUCKET AND HAND PUMPED BACK INTO DIFF UNTIL FULL. FILL UP FRONT DIFF WITH NEW OIL WAITED FOR OIL TO SETTLE THEN TOPPED OFF. DISCARDED BAD DIFF FLUID AND CLEANED PANS. GREASED DRIVELINE AND MADE SURE GREASE CAME OUT OF ALL JOINTS. DISCONNECTED SHOP AIR AND RECONNECTED AIR LINE TO COMPRESSOR.
